Tier 2 Reports: 1 incident was reported this quarter, by River King Oil, on Rte 3 & GG Rd. 250 gallons of produced water was spilled. The truck was passing through on the way to Campbell Hill.

Tier 2 Manager is up and running. Deadline for reporting is March 1, 2016.

We would like to start contacting local businesses and see if they need help doing their forms. Please contact Ryan if you are able to help make these calls.

Kevin will be attending the St. Clair County EMA meeting next week and will seek guidance on how to help companies fill out forms and how we can best identify those that need to file.

Mark said he will try to get a sample flier from other locations that send out public notices on the matter of companies reporting to the state.
